

SEPTEMBER HIGHLIGHTS

The Worship Committee has planned one service at 10:30 AM on Sunday, October 6, which is also World Communion Sunday. After our worship service there will be a potluck luncheon in the Fellowship Hall. We will also hear reports from all church committees, with opportunities for everyone to volunteer for committees of interest. We encourage all LCOB members and visitors to join us on that day for worship, fellowship, good food, and an opportunity to volunteer to serve in an area of interest. God calls us to serve!

The Sacrament of Holy Communion will be celebrated on Sunday, September 29 at the beach service, as this is the last beach service for 2019. Thanks to all who have helped with the set-up for this service, and special thanks to Barbara Tyndall for her dedication each week in helping with set-up and clean-up at the beach.



The Session has approved a Tree of Life project for the church, creating opportunities for memorials for the congregation. Stay tuned for details!

A LCOB Security Committee has been established to address security issues for the church building and parking lot. This committee has met and security needs are being addressed by the Property Committee.

In addition, this committee recommended, and the Session has approved, a plan to have an off-duty law enforcement officer on our premises on Sunday mornings: 8:00 AM - 12:00 Noon.

The purpose of this officer will be to provide security for worship services. Details are being worked out at present and the congregation will be notified of arrangements when in place. Ed O'Neil has volunteered to chair this committee.

The Finance Committee will begin working on the 2020 budget and all committees are asked to present their budget requests to this committee by October 27.

We plan to welcome new members on October 6 at the 10:30 AM Worship Service. An information gathering will be held at the manse, 11 W. Oxford Street, on Tuesday, October 1 at 6:30 PM. Church officers will be present to welcome these new members, enjoy fellowship, and to acquaint them with church policy and practices.



The Worship Committee has been planning our Advent and Christmas activities. An Advent Devotional Booklet will be developed using

meditations written by church members based on suggested Scripture readings. Details will follow soon, with opportunities for all to participate in this Advent project.

The Presbytery of Coastal Carolina will meet on Saturday, October 12 in Dunn. Elder Beckey Smith will be the LCOB Elder Commissioner.

Holiday Parking Lot receipts for the three holiday weekends totaled \$8839.95. These funds are designated for missions and are distributed by the Mission Committee. Special thanks to all those parking lot volunteers who worked long hours in the summer heat to collect these funds for our various mission activities.

John Copeland (left) and Al Wordsworth are co-moderators of Little Chapel's Finance Committee. They recently provided answers to questions about their committee's mission, work, responsibilities, and challenges. Thanks, Al and John for helping us better understand the workings of the committee.

Q. The finance committee has as its mission to supervise the financial affairs of Little Chapel.

Let's start with the budget. Explain the budgeting process and your working relationship with other committees, Session, Board of Deacons, church staff, etc.

A. The budgeting process allows the church to plan future expenditures based on the expected funds available to the church. The finance committee's role in this process is to work with the other committees of the church to make sure the proposed expenditures are in line with the expected funding.

Once the budget is established the finance committee provides periodic reporting updates to facilitate keeping the church within the budget.

Q. Most of the funding for our annual budget comes from our members' pledges and offerings.

Why is it important for our members to pledge?

A. It is important for members to pledge as this provides a reliable estimate of funds that will be available for future expenditures. This in turn allows church committees to plan for the coming year and make sure the church funds are used in an appropriate manner.

Q. It's very likely that many of our members use automated bank drafts or automated credit card withdrawals for paying routine monthly bills (power, water, loans, etc.), yet very few take advantage of Little Chapel's bank draft withdrawals to fulfill their pledge commitments. Do you have any explanation why that is?

A. Many members may not know about that this program is available. Members should consider using it if they feel it would be convenient

Q. The committee also oversees the endowment fund. What's the status of the fund, plans, concerns?

There is an endowment committee that oversees the administration of the fund and Wells Fargo manages the

investments. The fund has benefited from the stock market being at record levels. The YTD return has been 10.4%. Since inception the return has been 7.3%.

The endowment committee makes periodic distributions from the fund. The distributions are currently focused supporting charities that feed and service children in our area.

The July distribution provided \$27,092 to local charities, \$5,806 to the Capital Improvement fund and \$5,806 to the Insurance deductible fund.



Q. Since we are still in hurricane season, let's talk insurance.

Are all 3 properties covered under the same policy or are there special considerations for each? What are our annual insurance costs?

A. With our location in Wrightsville Beach insurance is a necessary and significant expense. Property insurance cost \$40,000 per year and flood insurance is \$18,400. Combined we are paying about \$1,100 per week for insurance premium.

In addition to the premium the property insurance deductible is in the range of \$26,000.

Q. The damage done due to hurricane Florence -- were we adequately covered? Any adjustments for this year?

A. The roof of the church had to be replaced after Florence. The work is nearing completion and hurricane Dorian provided a good test to see if there are any leaks.

The church is still in the process of submitting evidence of expense to the insurance company. All indications are the insurance company will reimburse the church for the claimed amount, but this is still in process.

Q. What is the finance committee's' role or duty in insuring prudent financial decisions? Explain how and

how often Little Chapel is audited and what the results of the audit reveal.

A. The Session manages the affairs of the church. This is a dedicated group of people that are cautious/prudent with the church funds.

Expenditures are discussed and this group works hard to put available funds to a good use. The church financial statements are reviewed annually by an independent agency. The most recent review did not find any major issues.



Q. Explain Little Chapel's scholarship, memorials, and gifts policies for us.

A. Glad you asked this question as I have not seen the policy that covers this.

What I know -

There have been members who have granted memorial and scholarship funds that the church administers. Some grants are earmarked for a specific use and others have been granted to a general fund.

There is a scholarship committee that meets each May to review scholarship applications and grant awards.

Q. Does Little Chapel have any outstanding loans?

A. The church has a \$50,000 line of credit available for use. We have not had to use the line of credit recently, but we keep it open in the event we get an unexpected expense.

Q. We all should know Little Chapel's infrastructure has limited life. What short and long-range plans are there for replacement? Are there any capital fund campaigns in the making?

A. The property committee does an excellent job of maintaining the church facilities.

The plan is to continue to keep the facility structurally sound and it should last for years. The endowment committee did provide \$5,806 of capital funding in July.

the annual Also, during budget process some funds are set aside to cover unexpected maintenance actions. Each year the fund balance capital reviewed for possible funding increases.



Please help us keep the narthex a welcoming space. With pastries and coffee and our new kiosk in the narthex, we are limited in space and so the Session has requested that all fundraising activities happen in the fellowship hall.

This will allow for the narthex to be a place where people can be welcomed into worship.




